**14** Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶

On March 5, 2025, the Conversion Rate applicable to the 0.00% Convertible Senior Notes due 2026 was adjusted to 6.4526 shares of Common Stock per \$1,000 principal amount of Notes as a result of cash dividends made to holders of the Common Stock since the most recent adjustment on December 19, 2024.

**15** Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶

The conversion rate adjustment will be reported as a dividend (on Form 1099-DIV) in the amount of \$5.10 per \$1,000 principal amount of Notes based on the closing share price on the trading day prior to the March 5, 2025 ex-dividend date, and which dividend amount increases a holder's basis in its Notes.

**16** Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ▶

The amount of the dividend as a result of the conversion rate adjustment is the excess of (i) the fair market value of the right to acquire the stock immediately after the adjustment, over (ii) the fair market value of the right to acquire the stock without the adjustment, and the Company's determination of the change in the fair market value of the right to acquire the stock was based in part on the amount of the cash dividend paid to holders of the Common Stock, which cash dividend resulted in the conversion rate adjustment.
